- an executed copy of the amended Article(s), verified by an Affidavit of Execution (Form SA0133),
- declaration required under Section 266(1) of the Cooperative's Act (Form SA0095A),
- if a new name is adopted, an Alberta Name Search Report (from the NUANS database) is required dated not more than 90 days prior to the date the Articles of Amendment are received by the Alberta Government,
- Notice of Initial Execution/Termination of a Unanimous Agreement (Form SA0090), if applicable,
- Notice of Address/Change of Address (Form SA0091), if applicable,
- Notice of Directors/Change of Directors/Change of Director's Address (Form SA0088), if applicable, and
- Summary of Articles of Incorporation (Form SA0089) if the amendment changes any of the following:
 - type of cooperative,
 - objectives,
 - classes of shares and any maximum number of shares that the cooperative is authorized to issue,
 - restrictions on share transfers,
 - number or minimum and maximum number of directors,
 - if the cooperative is restricted from carrying on a certain business or restricted to carrying on a certain business, or
 - fiscal year end.
