**INSTRUCTIONS**

**This form is used to complete the extra-provincial registration of an Alberta corporation in British Columbia in compliance with the provisions of the Trade, Investment and Labour Mobility Agreement (TILMA).**

- Item 1. Enter the name of the corporation, Alberta corporate access number and Alberta registration date.
- If the corporation is a successor corporation resulting from amalgamation, provide all the amalgamating corporations by indicating the name of the corporation, AB corporate access number and BC registration number if extra-provincially registered in BC. Use additional sheet when required.
- Item 2. Enter the extra-provincial assumed name, if applicable.  
Enter the extra-provincial name request number, if applicable.  
Enter the federal business number, if obtained.  
Enter the name of the authorized signing authority (authorized representative).
- Item 3. Enter the full name, telephone number and mailing address of the submitting party.
- Item 4. Enter the head office mailing address. This address can be a post office box.  
Enter the head office delivery address. The location must be accessible to the public from 9:00 am – 4:00 pm on business days and cannot be a post office box.
- Item 5. Enter the full name of attorney(s). The attorney must be either, an individual who is resident in BC **or** a corporation located in BC.  
Enter the full attorney mailing address. This address must be in BC and can be a post office box.  
Enter the full attorney delivery address. The location must be in BC and accessible to the public from 9:00 am – 4:00 pm on business days. This address cannot be a post office box.

The form must include:

- Title (relationship to corporation)
- Signature
- Date signed
- \$30.00 Name Search fee. Make cheque payable to the Minister of Finance.  
**(Name Search fee is not required when the extra-provincial name request number is provided on the form.)**
