INSTRUCTIONS

This form is used to complete the updates to the attorney records of an Alberta corporation extra-provincially registered in British Columbia in compliance with the provisions of the Trade, Investment and Labour Mobility Agreement (TILMA).

Item 1. Enter the name of the corporation and Alberta corporate access number.

Item 2. Enter the extra-provincial registration number in British Columbia.

Select one type of amendment.

Enter the name of the authorized signing authority (authorized representative).

Item 3. Enter the full name and mailing address of the submitting party.

Item 4. Enter the full name of attorney(s) and attorney addresses as they should have been recorded. The attorney must be either, an individual who is resident in BC **or**, a corporation located in BC.

Enter the full attorney mailing address. This address must be in BC and can be a post office box.

Enter the full attorney delivery address. The location must be in BC and accessible to the public from 9:00 am – 4:00 pm on business days. This address cannot be a post office box.
