



Odometer Fraud

This publication is intended to provide general information only and is not a substitute for legal advice.

Alberta Transportation will contact Albertans when they register a vehicle with an odometer reading lower than a previous reading reported by a prior registered owner. This discrepancy could be the result of data entry error or odometer tampering.

If a data entry error was made, please contact Alberta Transportation Vehicle Safety Section and correct the record. You may need to provide documentation to verify the requested change.

Tampering with an odometer is illegal in Alberta. Purchasers of used vehicles who learn that the odometer has been turned back should first try and resolve the issue with the seller.

- If you bought the vehicle through a private sale or from an Alberta automotive dealer, you may ask the seller to refund your money. (Even if the sale is “as is” tampering with the odometer is against the law.)
- If you want to keep the vehicle, ask the seller to pay you the difference between the purchase price and the value of the vehicle with a higher odometer reading.

If these alternatives are not successful you can file a complaint with the Alberta Motor Vehicle Industry Council (AMVIC). AMVIC licenses automotive salespeople and dealerships and may be able to investigate your odometer reading complaint. You may also want to:

- file a police report
- file a court claim if the seller will not refund your money.

HELP PREVENT ODOMETER FRAUD

Next time you register a vehicle or renew a registration at an authorized registry agent location, provide your vehicle odometer reading to Service Alberta Registries.

SPOT A TAMPERED ODOMETER

- Is the used vehicle’s odometer reading unusually low (under 20,000 km/yr)?
- Are the digits misaligned?
- Is the trip odometer working?
- Are one or more dash screws loose or missing?
- Are there scratches near the odometer?
- Check the dates on oil change labels. Are they consistent with the odometer readings?
- Is the vehicle registration information inconsistent with the odometer reading?
- Check for wear and tear of the door strikers, floor mats, carpets, driver’s seat and gas/brake pedals. Is it consistent with the age of the vehicle and the odometer reading?
